

## 5 Thai Burma Relations International Idea

This book examines the concept of peace and the relevance of historical and contextual factors that contribute to peaceful coexistence of people, and dives into a deep examination of how democracy furthers peace especially in conflict prone countries. Seven case studies illustrate the impact of democratization on transformation and prevention.

An examination of the plight of the refugees of Burma's protracted civil war, many of whom have fled across the border into Thailand. This book provides crucial insights into the worldwide phenomenon of refugee flows into urban settings, repercussions for those seeking protection, and the agencies and organizations tasked to assist them. It provides a comparative exploration of refugees and asylum seekers in nine urban areas in Africa, Asia and Europe to examine issues such as status recognition, international and national actors, housing, education and integration. The book explores the relationship between refugee policies of international organisations and national governments and on the ground realities and demonstrates both the diverse of circumstances in which refugees live, and their struggle for recognition, protection and livelihoods.

After decades of mismanagement and direct military rule, Myanmar's contested transition to a more democratic government has rapidly shifted the outlook in this significant Southeast Asian nation. Since 2011, the removal of Western sanctions and new foreign investments have resulted in high rates of economic growth and an expanding middle class, albeit from a very low base. In a result unthinkable a few years earlier, former political prisoner and Nobel laureate, Aung San Suu Kyi, and her party, the National League for Democracy (NLD), formed a national government in early 2016.

However, despite significant political and economic reforms since the liberalisation process commenced, the transition to civilian rule remains constrained by the military's 2008 Constitution, which guarantees that it operates unfettered by civilian oversight. As a result, although some ethnic conflicts have abated, others continue to fester while new conflicts

have erupted. With a daunting task ahead the NLD government has made some progress in removing the vestiges of repressive military-era laws but many remain untouched and some of the practices of the new government provide unwelcome reminders of its authoritarian history. This timely Handbook describes the political, economic, cultural and strategic dimensions of this crucial period of transition in Myanmar life. It presents explanations for contradictory trends, including those that defy some of the early narratives about the comprehensive transformation of Myanmar life. The Handbook also considers the impact of major environmental, strategic, demographic and cultural trends which help in understanding that Myanmar's development will be an ongoing task. In addition to introductory and concluding chapters by the editors, the body of the Handbook is divided into seven core sections: • Fundamentals • Spaces • Cultures • Living • Governance • International • Challenges Written by an international team of scholars, with a mix of world-leading established academics and up-and-coming researchers, the Handbook provides a rigorous scholarly overview of Myanmar's politics, economics and society. As Myanmar opens to Western businesses and government agencies, it is an invaluable reference book that will provide a foundation for further research and offer the first port of call for scholars, students and policy makers working on Myanmar and Asia.

This book analyzes Myanmar's contemporary political history, arguing that Myanmar's so-called "democratization" has always been a calculated regime transition, planned by the military, with every intention that the military to remain the key permanent political actor in Myanmar's political regime. Using the period since Myanmar's regime change in 2011 as an extended case study, this book offers an original theory of regime transition. The author argues that Myanmar's ongoing regime transition has not diverged from its authoritarian military roots and explains how the military has long planned its voluntary partial withdrawal from direct politics. Therefore, Myanmar's "disciplined democracy" contains features of democratic politics, but at its core remains authoritarian. Providing an original contribution to the theoretical literature on regime change by developing a theory of trial and error regime transition, the book engages with and challenges the popular democratization theory by arguing that this theory does not sufficiently explain hybrid regimes or authoritarian durability. Additionally, the book adds to an alternative understanding of how the regime transition was initiated by examining the historical evolution of Myanmar's post-colonial regime and offers a fresh perspective on contemporary political developments in Myanmar. An important contribution to the study of authoritarian durability and the dynamics of regime change in Southeast Asia, this book will be of interest to academic researchers of comparative politics, international relations, and Southeast Asian studies.

Refugee camps are imbued in the public imagination with assumptions of anarchy, danger and refugee passivity. *Governing Refugees: Justice, Order and Legal Pluralism* challenges such assumptions, arguing that refugee camps

should be recognized as spaces where social capital can not only survive, but thrive. This book examines camp management and the administration of justice in refugee camps on the Thailand-Burma border. Emphasising the work of refugees themselves in coping with and adapting to encampment, it considers themes of agency, sovereignty and legal pluralism in an analysis of local governance and the production of order beyond the state. *Governing Refugees* will appeal to anyone with relevant interests in law, anthropology and criminology, as well as those working in the area of refugee studies.

Across the world states are seeking out new and secure supplies of energy but this search is manifesting itself most visibly in Asia where rapid industrialisation in states such as China and India is fomenting a frantic scramble for energy resources. Due to entrenched societal inequities and widespread authoritarian governance, however, the pursuit of national energy security through transnational energy projects has resulted in devastating impacts on the human and environmental security of local populations. These effects are particularly evident in both Thailand and Myanmar (Burma), which, located at the crossroads of Asia, are increasingly engaged in the cross-border energy trade. Based on extensive fieldwork and theoretical analysis this ground-breaking book proposes a new critical approach to energy and environmental security and explores the important role that both local and transnational environmental movements are playing, in the absence of effective and democratic governments, in providing 'activist environmental governance' for energy projects throughout the region. By comparing the nature of this activism under two very different political regimes it delivers crucial theoretical insights with both academic and policy implications for the sustainable and equitable development of the South's natural resources.

Myanmar's security forces have conducted clearance operations in the Rakhine State since August 2017, driving a mass exodus of ethnic Rohingyas to neighboring Bangladesh. In *The Rohingya Crisis: Analyses, Responses, and Peacebuilding Avenues*, Kawser Ahmed and Helal Mohiuddin address core questions about the conflict and its global and regional significance. Ahmed and Mohiuddin identify the defining characteristics of Rohingya identity, analyze the conflict, depict the geo-economic and geo-political factors contributing to the conflict, and outline peacebuilding avenues available for conflict transformation at the macro-, meso-, and micro-level. This book is recommended for students and scholars of anthropology, sociology, peace and conflict studies, political science, and Asian studies.

While there is abundant literature discussing non-traditional security issues, there is little mention of such issues existing in the South China Sea. This area is vulnerable to natural hazards and marine environmental degradation. The marine ecosystem is threatened by various adverse sources including land-based pollution, busy shipping lanes, and over-exploitation activities which threaten the security of the surrounding population. This area is also threatened by piracy and maritime crimes but law enforcement becomes difficult due to unclear maritime boundaries. This volume is designed to explore the security cooperation and regional approaches to these non-traditional security issues in the hope to build a peaceful environment and maintain international and regional security and order in the South China Sea region. Few states in the contemporary world present the complexities that characterize Burma/Myanmar at present. On the one hand, it has been under military rule for some forty-four years at this point, with many traditional factors in operation: an high degree of authoritarianism; the dominance of personalization over institutions; powerful centrism, but with a progressive weakening as the distance from the center lengthens; and the importance of religion as a source of identity. Those who govern Myanmar have given ample indication in recent times of a desire to interact with diverse international bilateral and multilateral operations. Yet Burma/Myanmar nationalism has contained a

xenophobic quality emphasized on occasion, a proclivity that is more conducive to isolation than to cooperation. In this context, the movement of the capitol from Rangoon to Pyinmana in the interior, while proclaimed as a move to provide easier access to all parts of Myanmar raises questions. Moreover, as was demonstrated recently, in the face of strong opposition, Myanmar was prepared to give up its scheduled chairmanship of ASEAN rather than to change its domestic political policies. Under the circumstances, it is fortunate to have a highly regarded scholar who has spent many years undertaking in-depth studies of Burma/Myanmar as well as other parts of East Asia, with a history of friendships and research in the region, provide us with an up-to-date analysis. David Steinberg presents a broad picture of the complex scene, commencing with a presentation of key theoretical and historical considerations, and proceeding to an analysis of various specifics relating to the current Burma/Myanmar society and state. His analysis is comprehensive and balanced, taking into account the many complexities and uncertainties of this troubled state. Soldiers and Diplomacy addresses the key question of the ongoing role of the military in Burma's foreign policy. The authors, a political scientist and a former top Asia editor for the BBC, provide a fresh perspective on Burma's foreign and security policies, which have shifted between pro-active diplomacies of neutralism and non-alignment, and autarkical policies of isolation and xenophobic nationalism. They argue that important elements of continuity underlie Burma's striking postcolonial policy changes and contrasting diplomatic practices. Among the defining factors here are the formidable dominance of the Burmese armed forces over state structure, the enduring domestic political conundrum and the peculiar geography of a country located at the crossroads of India, China and Southeast Asia. Egreteau and Jagan argue that the Burmese military still has the tools needed to retain their praetorian influence over the country's foreign policy in the post-junta context of the 2010s. For international policymakers, potential foreign investors and Burma's immediate neighbors, this will have strong implications in terms of the country's foreign policy approach.

Critically but sympathetically interrogating Italian philosopher Giorgio Agamben's analysis of the logic of sovereign power, this volume draws attention to the multiple zones of exclusion in and through which contemporary international politics constitutes itself. Beginning from the margins and peripheries of world politics, this book emphasises the colonial processes through which contemporary "third world" spaces of exception have been shaped and particular bodies made susceptible to the conditions of "bare life". The authors contend that these bodies inhabit a variety of spaces or "zones of indistinction" that include political detainees, refugees, asylum-seekers, poor migrants, sweatshop workers, and unassimilated indigenous populations. These are the "expendable bodies" that the territorial and market-driven logic of current international relations simultaneously produces, polices and excludes. Focussing on the locally and socio-historically specific ways that sovereign power works, the individual chapters provide the volume with a wide geographical reach. Drawing on diverse approaches, this text constitutes an important intervention in critical international relations, providing grounded theory and sophisticated analyses of how contemporary international relations works through the production of 'exceptions'. Bringing together a range of internationally-renowned scholars, *International Relations and States of Exception* will be of vital interest to students and scholars of International Relations, Critical Theory and Postcolonial Studies.

For over sixty years, conflict between state forces and armed ethnic groups was ongoing in parts of the borderlands of Burma. Ethnic minority communities were subjected to systematic and widespread abuses by an increasingly complex patchwork of armed state and non-state actors. Populations in more remote and disputed border areas typically had little to no access to even basic healthcare and education services. As part of its counter-insurgency campaign, the military state also historically restricted international humanitarian access to civilian populations in unstable border areas. It was in this context that "cross-border aid" to Burma had developed, as an alternative mechanism for channelling assistance to populations denied aid through more conventional systems. Yet by the late 2000s, national and international changes had significant impacts on an aid debate, which had important political and ethical implications. Through an ethnographic study of a cross-border aid organisation working on the Thailand-Burma border, this book focuses on the political and ethical dilemmas of "humanitarian government". It explores the ways in which aid systems come to be defined as legitimate or illegitimate, humanitarian or "un-humanitarian", in an international context that has witnessed the multiplication of often-conflicting humanitarian systems and models. It examines how an "embodied history" of violence can shape the worldviews and actions of local humanitarian actors, as well as institutions created to mitigate human suffering. It goes on to look at the complex and often-invisible webs of local organisations, international NGOs, donors, armed groups and other actors, which can develop in a cross-border and extra-legal context – a context where competing constructions of systems as legitimate or illegitimate are highlighted. Bill Pritchard provides an important update on how current trade methodologies are implemented as China becomes one of the world's largest fresh fruit importers from countries such as Laos, Myanmar, Thailand and Vietnam.

With the world watching closely, Myanmar began a process of political, administrative and institutional transition from 30 January 2011. After convening the parliament, elected in November 2010, the former military regime transferred power to a new government headed by former Prime Minister (and retired general), U Thein Sein. With parliamentary processes restored in Myanmar's new capital of Naypyitaw, Thein Sein's government announced a wide-ranging reform agenda, and began releasing political prisoners and easing press censorship. Pivotal meetings between Thein Sein and Aung San Suu Kyi led to amendment of the Election Law and the National League for Democracy contesting by-elections in April 2012. The 2011 Myanmar/Burma update conference considered the openings offered by these political changes and media reforms and the potential opportunities for international assistance. Obstacles covered include impediments to the rule of law, the continuation of human rights abuses, the impunity of the Army, and the failure to end ethnic insurgency.

Millions of children around the world are affected by conflict, and the enduring aftermath of war in post-conflict societies.
