**BACKGROUND:** The journal Mental Health, Religion & Culture (MHRC) recently celebrated its 21st anniversary, having commenced publishing in 1998. MHRC provides an authoritative forum and a single point of reference for the growing number of clinicians and academics working in the expanding field of mental health and religion. Over the course of the last two decades, well over 1,000 research articles have been published in MHRC. In acknowledgement of this anniversary, the aim of the present study was to provide a retrospective bibliometric assessment of MHRC over its initial 21 years of production. **METHOD:** All previously published articles in MHRC (1998-2018) were empirically examined by two analytical tools: Google Scholar and SCImago Journal Rank (SJR indicator). **RESULTS:** The data provided a wide range of findings. First, various scholarly metrics including impact factor, five-year impact factor, h5-index, number of citations received, and self-citation rate were presented. Second, the most cited articles were identified and the common themes of these publications were explored. Third, the international diversity of the journal's author base was outlined. Furthermore, a list of Special Issues published by MHRC was also presented. **DISCUSSION:** The findings were discussed and common themes were outlined. Moreover, current gaps in the literature were also identified that could be examined in future articles, including Special Issues, of MHRC. The utility of MHRC for disseminating research on psychiatry and religion is highlighted.

Social psychiatry is concerned with the effects of the social environment on the mental health of the individual, and with the effects of the person with a mental disorder on his/her social environment. The field encompasses social interventions, prevention and the promotion of mental health. This new edition of Principles of Social Psychiatry provides a broad overview of current thinking in this expanding field and will be a source of ideas both in research and for the management of mental disorder. It opens by putting social psychiatry in perspective, within both psychiatry and the social sciences. The book reviews the social determinants and consequences of the major mental disorders before considering interventions and service delivery at various levels to mitigate these. It closes with a review of the social impact of mental illness around the world and a thoughtful essay by the editors on the current state of social psychiatry and where it is heading.

The NATO Advanced Study Institute on the Prevention of Crime and Violence Among the Mentally Ill was held in May 1999 in Tuscany, Italy. Participants from 15 countries attended. Since care for persons with mental illness (schizophrenia, major depression, bipolar disorder, delusional disorder, atypical psychoses) has been deinstitutionalized, some persons with these disorders are committing crimes and serious violence. Consequently, societies around the world are confronted with a new challenge: to provide mental health care and social services to mentally ill persons in a humane way that will prevent illegal behaviours. Research in this field has been dominated by investigations designed to improve clinicians' accuracy in predicting violent behaviours, with little attention focused on the organization and implementation of treatments. The premise of the Advanced Study Institute was that treatments must have empirically proven efficacy. Both professional

ethics and public accountability require empirical evidence that each treatment will alleviate the problem that it targets. However, despite the fact that Western industrial societies provide treatment for mentally ill persons who have offended, there is a very limited base of knowledge on what constitutes effective treatment and how such treatments should be organized and delivered. The Advanced Study Institute was an attempt to stimulate and encourage research that will extend this knowledge base. The goals were to review what is known about mentally ill offenders and about effective treatments for them, and to provide a framework for the orientation of future investigations designed to improve treatment efficacy.

Over the last two decades, the number of persons over 65 has increased by 65%. Handbook of Clinical Geropsychology focuses attention on how the contributions of clinical psychology address the problems faced by this enormous population. In the first part, chapters cover a historical perspective, clinical geropsychology and U.S. federal policy, psychodynamic issues, and other key topics. Part II details assessment and treatment for a wide range of disorders affecting the elderly. Part III considers such special issues as family caregiving, minority issues, physical activity, and elder abuse and neglect.
