The NATO Advanced Research Workshop, “Decision Support for Natural Disasters and Intentional Threats to Water Security” was the result of close collaboration between environmental, security, water resource, and health officials in the United States and Croatia. The premise of the Workshop is that multiple, disparate threats to water security exist, and that shared decision

support structures provide effective means for avoiding and responding to potential or actual situations. The Workshop was co-directed by Professors Tissa Illangasekare of the Colorado School of Mines, and Dragutin Geres of Hrvatske vode. The Workshop was organized into a series of case studies, presentation of management tools, or a combination of the two. Presentations were further organized as to (1) Natural Occurrences, (2) Anthropogenic Causes, and (3) Decision Support Tools. Delegates from eleven countries assembled to explore these topics at the Hotel Dubrovnik President in Dubrovnik from April 22–25, 2007. A total of thirty delegates from NATO, Partner, Mediterranean Dialog, or other countries were in attendance. The final program included technical sessions using a presentation and dialog format, a field trip, and networking sessions. This book explores the interconnection between geopolitical context and the ways this context frames our knowledge about Asia, highlighting previously neglected cause-effect relations. It also examines how various knowledge institutions promote and shape Asian Studies. The authors seek to explain why Asian Studies and its subfields developed in the way they did, and what the implications of these transformations might be on intellectual and political understandings of Asia. The book not only builds on the current debates on the decolonization and de-imperialization of knowledge about Asia; it also proposes a more multifaceted view rather than just examining the impact of the West on the framing of Asian Studies.

This book is based on empirical research in Sri Lanka conducted after the catastrophic tsunami which hit the country in December 2004. The aims of the research have been to develop new knowledge on post-crisis reconstruction and recovery work, on how to bridge the knowledge gap between researchers and practitioners, as well as trying to use past research experiences from Sri Lanka to learn about the present day situation. The chapters use a common analytical frame related to the 'policy narratives' of post-tsunami recovery in the shadow of war, and deal with housing reconstruction, livelihoods, internally displaced, humanitarian interventions and protracted conflicts. The authors represent various social scientific fields and they have experience from different geographical areas of Sri Lanka. This book was published as a special issue of Norsk Geografisk Tidsskrift.

The Rio+20 UN conference specifically drew attention to the green economy approach in the context of sustainable development to move away from business-as-usual practices, act to end poverty, address environmental destruction and build a bridge to the sustainable future. It is increasingly recognized that the tourism sector can make a major contribution to the green economy through more sustainable practices, climate change mitigation and ecotourism. The role of tourism sector will continue to be crucial in the post-2015 sustainable development agenda too. This book presents a collection of papers under the theme of multi-hazard early warning and disaster risks. These were selected from the presentations made at the International Symposium on Tsunami and Multi-Hazard Risks, Early Warning and Community Awareness in supporting implementation of the Sendai Framework for Disaster Risk Reduction 2015-2030. This conference aimed to recognize achievements and to highlight work that still needs to be carried out. The conference promoted collaboration among academia, research institutions and disaster management offices, and further encouraged multidisciplinary and multi-sectoral interaction. This International Symposium on Multi-Hazard Early Warning and Disaster Risk Reduction provided an important opportunity to reflect upon our progress to date in tackling disaster risk, but also to consider some of the challenges and opportunities that lay ahead of us. A particular focus of this event was Multi-Hazard Early Warning. During the negotiations for the Sendai Framework, countries and partners highlighted the need to: 1. Continue to invest in, develop, maintain and strengthen people-centred, end-to-end early warning systems; 2. Promote the application of simple and low cost early warning equipment and facilities; 3. Broaden the dissemination channels for early warning information to facilitate early action. Countries also called for the further development of and investment in effective, nationally compatible, regional multi-hazard early warning mechanisms. To address these needs, global Target (g) of the Sendai Framework was adopted, namely to "substantially increase the

availability of and access to multi-hazard early warning systems and disaster risk information and assessments to the people by 2030". As illustrated by recent events in Indonesia, it is also vital to address the challenge of cascading hazards that pose a tsunami risk, and the importance of linking tsunami early warning to a multi-hazard environment. However, moving towards a multi-hazard environment is complex and poses many challenges but can bring significant benefits in terms of efficiencies and also in recognising the links between hazards, such as cascading threats. We very much hope that this book will provide an important platform to address these and other challenges in addressing disaster risk, as well as supporting implementation of the Sendai Framework for Disaster Risk Reduction

This book presents selected papers from the 7th International Conference on Water and Flood Management, with a special focus on Water Security under Climate Change, held in Dhaka, Bangladesh in March 2019. The biennial conference is organized by Institute of Water and Flood Management of Bangladesh University of Engineering and Technology. The recent decades have experienced more frequent natural calamities and it is believed that climate change is an important driving factor for such hazards. Each part of the hydrological cycle is affected by global climate change. Moreover, increasing population and economic activities are posing a bigger threat to water sources. To ensure sustainable livelihoods, safeguard ecosystem services, and enhance socio-economic development, water security needs to be investigated widely in a global and regional context.

This is the first book to examine war and violence in Sri Lanka through the lens of cross-cultural studies on just-war tradition and theory. In a study that is textual, historical and anthropological, it is argued that the ongoing Sinhala-Tamil conflict is in actual practice often justified by a resort to religious stories that allow for war when Buddhism is in peril. Though Buddhism is commonly assumed to be a religion that never allows for war, this study suggests otherwise, thereby bringing Buddhism into the ethical dialogue on religion and war. Without a realistic consideration of just-war thinking in contemporary Sri Lanka, it will remain impossible to understand the power of religion there to create both peace and war.

This work is intended for advanced readers interested in methods of sustainable land management - the prevention and control of land degradation. It offers a coherent view of the situation concerning land degradation and the human response to the problem. It is generally recognized that technological solutions alone cannot solve the problems of land degradation. This book discusses the role of land use and land management policies, programmes, insitutional innovations, and economic incentives for the control and prevention of land degradation. Special attention is given to legal issues at the international level and in individual countries.
